## What UW Officials Are Hiding About the **Late-Term Abortion Plan** at the Madison Surgery Center

*The following information is from emails between various UW officials obtained through an open records request.*

- ▶ **Most of the late-term abortions will be performed simply because the woman wants one**
- ▶ **Attorneys hope the Obama administration will give them wiggle room to decide whether employees will be forced to participate in late-term abortions**
- ▶ **Officials state they may force employees to assist if there is an emergency following a late-term abortion**
- ▶ **Abortionist Caryn Dutton discloses that Planned Parenthood Federation of America's confidence in her ability to perform late-term abortions is "very LOW"**
- ▶ **UW officials worry that the plan could "put our whole operation at economic risk" as patients and doctors avoid the Madison Surgery Center**
